









BF569 Marking: LH Plastic case (SOT 23) 1 = Collector, 2 = Base, 3 = Emitter








Figure 2. Transition Frequency vs. Collector Current





Figure 3. Collector Base Capacitance vs. Collector Base Voltage


#### **Dimensions of BF569 in mm**



#### **Ozone Depleting Substances Policy Statement**

It is the policy of Vishay Semiconductor GmbH to

1. Meet all present and future national and international statutory requirements.

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.
